006	<ul> <li>Where emergency treatment is provided:</li> <li>a. during working hours, and the provision of such treatment requires the practitioner to leave her or his practice to attend to the patient in hospital; or</li> <li>b. after working hours the fee for such visits shall be the total fee plus 50%.</li> <li>For purposes of this rule:</li> <li>a. \""emergency treatment\"" means a bona fide, justifiable emergency occupational therapy procedure, where failure to provide the procedure immediately would result in serious impairment to bodily functions or serious dysfunction of a bodily organ or part, or would place the person's life in serious jeopardy; and</li> <li>b. \""working hours\"" means 8h00 to 17h00, Monday to Friday.</li> <li>Modifier 0006 must be quoted after the appropriate code number(s) to indicate that this rule is applicable.</li> <li>Rule 006 does not apply to art therapy.</li> </ul>
